Travel Checklist for Overseas Participants of AAAP 2022

(as of June 15th, 2022)

South Korea imposes arrival restrictions for safe travel during the COVID-19 pandemic. We urge that you go through the procedure below carefully to ensure a successful entry to the country.

[PRE-DEPARTURE]

1. KETA (For Visa free/ waiver)

At least 72 hours before boarding your flight, you must complete the K-ETA application online. The K-ETA is valid for 2 years from the approval date. The application fee is 10,000 KRW.

- You will need the following documents for the application process:
 - ✓ Your ID photo (digital file)
 - ✓ Your passport information
 - ✓ Debit or credit card to pay for the fee

2. Pre-departure Covid19 test

The mandatory quarantine for an entrant to Korea is lifted on June 8. There is no mandatory quarantine, regardless of your history of vaccination, a type of visa etc. (only those with confirmed infection will be quarantined).

All travelers entering South Korea need to undergo either a pre-departure PCR test within 48 hours or a supervised Rapid Antigen Test within 24 hours before the departure date. (Regardless of vaccination status) The 'Negative' test result must be available before departure. Please have the paper-based test result at hand.

<Checklist for the Pre-departure Covid-19 test>

- PCR Test Result : issued within 48 hours prior to the departure date
- Rapid Antigen Test(RAT) Result: issued within 24 hours prior to the departure date
- Language of Certificate: The test result method must be written in English or Korean.
 (In case of other languages, a translation certificate must be accompanied)

3. Q-Code Registration

To be exempt from the quarantine, you are required to apply for a Q-Code. The application applies to travelers who are vaccinated in South Korea and abroad.

The Q-code registration will make your immigration process much more convenient. You will require the following documents to register.

- ✓ Passport information
- √ Vaccination certificate (in English)
- ✓ Travel itinerary and accommodation information
- ✓ Pre-departure PCR test result

[UPON ARRIVAL]

All passengers must take the arrival PCR test within 3 days after entry. You either take the test at the airport or at a COVID-19 screening facility near your accommodation.

You will have to remain in voluntary quarantine at your accommodation until your PCR test result is negative. We highly recommend taking the PCR test as soon as you arrive.

<Incheon Airport COVID-19 Testing Center>

If you are entering through Incheon Int' Airport, we highly recommend you to visit the Incheon Airport COVID-19 Testing Center. The airport testing centers are located in both Terminal 1 and Terminal 2. The operation hours are 7.00 - 21.00 every day with a break between 17.30-18.00. After taking the test, you can leave the airport by the public transportation or taxi to your accommodation and wait for your test result there.

We recommend that the participants who plan to stay in South Korea longer than the conference dates take a Rapid Antigen Test (COVID self-test) on the sixth or seventh day following the arrival date.
